



Charter Voucher

We, SeaStar Sailing SMPC, a Charter Company based in Athens, Greece, provide this voucher to **Mr. XXX (the Client)**, a xxxx citizen, who had booked an one week charter holiday starting on **xx/xx/2021**, aboard a yacht belonging to our fleet, through **YYYY (the Broker)**, a European Charter Broker based in yyyyyy, by paying the amount of **Euro zzzzz,00** as down-payment.

We have been informed by the **Broker** that the **Client** will be unable to utilize his charter contract, as a result of the special circumstances prevailing in Europe due to the COVID-19 pandemic.

We therefore accept the postponement of execution and re-scheduling of his charter contract for a date more convenient to him within the period of 18 months after **xx/xx/2021**, under the following conditions:

1. SeaStar Sailing has no obligation to deliver the yacht booked on the agreed date mentioned above, anymore.
2. The **Client** can apply the amount of money mentioned above, which he has already paid, as part of a new down-payment, towards a new Charter booking (with new terms and conditions) of any yacht in our fleet that he will re-select, for any time period (Saturday to Saturday) during the aforementioned period of time, through the same Charter Broker mentioned above, after evaluating the new conditions pertaining to the availability and the pricing terms applicable for the yachts of the fleet of SeaStar Sailing, at that time.
3. Should the **Client** be unable to re-schedule his Charter contract within this time period due to reasons related to the COVID-19 pandemic, SeaStar Sailing and the **Broker** hereby promise to return the amount mentioned above to the **Client** at the end of this period. SeaStar Sailing will fulfill this promise by returning the amount it has received from the Broker back to the Broker and the **Broker** will return the whole amount mentioned above with no fee charged (cancelation, re-booking or other) to the **Client**.
4. SeaStar Sailing retains the right to fulfill the number of cases of postponement of execution and re-scheduling that will have not been resolved within 2021, by accepting half of this unresolved number of cases for the year of 2022 and the other half for the year of 2023.
5. Subject to condition 4 above, SeaStar Sailing will treat this new Charter Booking by the **Client** with the same priority and in the same manner, as any other Charter Booking that it receives in the normal course of its business, following a first-come-first-served rule.
6. SeaStar Sailing is not obliged to offer the same yacht that was originally booked. The **Client** will select any yacht in the fleet of SeaStar Sailing, as this fleet will be composed and offered, at the time of his new booking.
7. It is mutually accepted that the **Client** has total freedom in selecting yacht, time period and specific date of the year and generally enter in a new Charter contract, not bound by any term of the original contract. Likewise, SeaStar Sailing is free to select yachts for its fleet and set appropriate prices according to the market conditions prevailing in the future and is no way bound by any term of the original contract.
8. SeaStar Sailing opens a booking schedule for the next year, during the end of the summer of the current year. It is not obliged to open a booking schedule for the year after next, during the current year.

This Voucher is valid, if it is signed by SeaStar Sailing, the **Broker** and the **Client** and must be presented to SeaStar Sailing by the **Client** prior to boarding.
